## Prescription Drugs 2006

Well, another big take away by Raytheon Company on our prescription drug program. Raytheon certainly isn't the company that we remember so fondly under Tom Phillips' direction.

The Plus plan will cover prescription drugs on a catastrophic benefit – that is after the Medicare D benefit is exhausted. It seems fairly certain that most retirees will pay more for prescriptions in 2006. First, you pay the premium for the Medicare D plan, second you will pay higher co-pays, and third any reduction in premium for the Plus plan (to be announced 11/15/05) will be much less than your Medicare D premium.

The following article on Medicare D choices will highlight the benefits of five plans

offered in Massachusetts since these plan details are available to me. But, the Medicare D plan offered in other states should be quite similar. We'll look at the four things Raytheon suggests you consider in comparing these plans:

- Monthly premiums
- Deductibles
- What you pay (co-pay or coinsurance)
- Formulary (list of drugs covered)

Please understand that I am not recommending any specific plans, but rather will provide an analysis of the plan designs and costs as a basis for you to do your own plan comparisons. Everyone's situation is different, so please use this report as a guide only.

### Medicare Part D Choices

Medicare has contracted with many prescriptions drug plans (PDPs) in each state to provide the drug coverage for eligible Medicare recipients. The PDPs must provide drug benefits at least equal to the standard Medicare D plan that we previously discussed in our newsletter. Through competition, many plans are offering better benefits than the standard plan and some at lower premiums than the \$35 per month set for the standard Medicare D plan.

In Massachusetts, we were given 44 separate plans to choose from. The materials are confusing and overwhelming even to someone who has spent many years in the benefits field.

This report will address the drug benefits only for the retirees who are enrolled in the Raytheon Medicare Plus plan. Those in Medicare HMO's such as BlueCare 65, Secure Horizons, and First Seniority in Massachusetts (now called Medicare Advantage Plans) should have drug benefits

similar to the current plan and do not have to enroll in Medicare D. You will get detailed information and premium rates on 11/15/05.

First, here is a simplistic overview of how your drug benefits will be delivered in 2006.

- Up to \$2,250 total drug costs by Medicare D Prescription Drug Plan
- \$2,251-\$16,500 total drug costs by Raytheon Drug Plan at 80%
- Over \$16,500 total drug costs by Medicare D Prescription Drug Plan at 95%.

Note: The \$16,500 total drug cost figure is when you have spent \$3,600 out-of-pocket because the Raytheon drug plan is paying 80% (and you 20%) after \$2,250 is reached.

**Medicare D Plan Illustrations**

The sources for the following information are Medicare & You 2006 by the U.S. Dept. of Health & Human Services, (note: the co-pay numbers are only for a 30-day retail supply), and telephone discussions with Blue Cross/Blue Shield of Massachusetts, Advantra Rx, and AARP Medicare Rx for plan details.

**Plan Analysis**

The very first thing you should do is to write a list of your medications so that you can determine which drugs are generic, preferred brand and non-preferred brand when you call the prescription drug plans (PDP’s). My wife has a drug that is covered as a preferred brand by Blue Medicare Options 1 & 2, and by Advantra Rx Premier Plus. However, AARP Medicare Rx, and Advantra Premier classify the drug as a non-preferred brand.

**Deductibles**

In reviewing the plan choices, it may be advisable to select one with a zero deductible. For a plan with a \$250 deductible you should add about \$21.00 a month to the premium when comparing the value of that plan.

**Premiums**

Next, the lowest premium is not necessarily the best deal. For example, if you have five or more prescriptions, the Blue Medicare Rx Option 2 and the Advantra Rx Premier Plus have higher monthly premiums, but when you factor in the lower co-pays, you may actually save money on an annual basis.

**Value**

For example, the annual costs to someone with a drug list of two generic, three preferred brands, and one non-preferred brand, and was buying a 90 day (3month) supply of each drug at a retail pharmacy would be:

\*Sample calculation of annual cost: \$240 (2x\$30x4)=(2 is the # of prescriptions X \$30 co-pay shown on chart on page two X 4 which is 360 days divided by 90 days).

A 90 day (3 month) supply through mail order would be:

As you can see the Advantra Rx Premier Plus plan has the highest monthly premium (\$42.89) of the four plans, but when you calculate the lower co-pays, Advantra Rx Premier Plus has the lowest total annual cost.

By the way, the costs of Blue Medicare Rx Options 1 & 2 could be even higher if the 25% coinsurance is greater than the co-pay. For example, if your co-pay for a brand drug is \$50, and the total cost of your prescription is \$300, then you will pay \$75 co-insurance (\$300 x .25) instead of \$50.

**General Observations**

You will be able to purchase a 90 day supply of maintenance drugs at retail pharmacies under some of these Medicare D plans.

Avoid buying any plans that have gap coverage, which is coverage when your total drug costs are between \$2,251 and \$5,100. The reason is that Raytheon’s Plus plan begins coverage when your total drug costs reach \$2,251. In effect, you’d be paying a much higher premium for duplicate coverage.

Check the prescription plan to make sure your drugs are on the formulary (their list of covered drugs). Some plans do not cover non-preferred brand drugs at all.

Most of the Prescription Drug Plans use the major chain pharmacies such as CVS, Walgreen’s, Wal-Mart and Costco, but probably won’t have contracts with your local independent drug store.

You enroll with the Medicare D Prescription Drug Plan (PDP) beginning on November 15. It would be advisable to enroll in your PDP by early December in order to get your drug card in time to be able to purchase drugs on January 2, 2006.

Ask your doctor for 90 day prescriptions dated January 1, 2006 for each of your medications for purchase under the new Medicare D plan if you plan to use mail order or your plan covers 90 days at a retail pharmacy.

Raytheon will be sending more information to you on November 15 on the Plus plan premiums and how their drug coverage will work with the Medicare D plans. Important: Select your Medicare D plan but do not enroll until you receive your Raytheon information package.

This new Medicare D drug benefit requires you to do some analysis to find the best plan for you. We hope that you find this article helpful in your decision-making.

## ARR News

### Farewell from Fred Churchill

I began working on the idea of a Raytheon retirees association six years ago, in the fall of 1999. I formed the Association in January 2001, beginning with a mailing to 500 retirees. Our mailing list has grown to over 12,000, and nearly 3,500 retirees have joined the Association. I have been working practically full-time since the beginning. I will be 83 on my next birthday and I have grown weary of my many tasks, including the newsletter. It is time to go and I resigned as President as of August 31, 2005. I will continue to be a member of the Board of Directors.

Unfortunately I cannot hand over my responsibilities to a successor as no one has offered to take on the job. Either for personal reasons or because of time constraints, none of the Directors was able to accept the position. A great effort was made to find a candidate among the recent, young retirees, but it was unsuccessful. In this situation the Directors have decided that they will form an operating committee, sharing the responsibilities of the President. The operating plan is explained by Mort Brond in an article in this issue, "ARR Organization – Operating Plan".

A cost-of-living pension increase is still the main issue for retirees. Progress has been slow because our effort has been limited. We must increase our efforts.

Recently the position of Raytheon with regard to a pension increase was clearly defined in an exchange of emails between Bill Swanson and me on the subject of a pension increase. He made these statements: "Pension increases are unaffordable period. The Company is not going to increase pensions we just can't fund additional liabilities." and "I am very sorry but no matter how well the company does it will only fund the gap (between pension plan assets and liabilities) not an increase in benefits.". This is a very clear statement of the company's position. What we need to do is to change that position and that is what we are working

toward. There is no way to measure our progress – 40%? 60%? – we will only know when we get the pension increase that we have reached 100%.

On leaving I want to thank the many individuals who helped me over the years. Their generosity was exceptional. There were the mailers who accepted batches of 240 packages, and they attached mailing labels and stamps to envelopes, and folded and stuffed solicitation packages, or newsletters, and sealed the envelopes, and took the lot to the post office. I am sure in most cases their spouses also deserve thanks. Their names are: Bob Brandon, George Kacek, John Collins, Mike Bleday, Fred Cronin, Dick Wright (Acton), Ed Johnson (Littleton), Judith Smart, Harry Barker, Robert Harper, Bob Hamilton, Mal Arnum, Tina Erbafina, Florence Mulkern, Lenny Hill, Stan Casazza, Dan Brzezinski, Dick Lynch, Conrad Klock, and Lorraine Civetti, And there were the data entry people (hunt-and-peck types) who supported at a distance the ARR record-keeping during a boom period of recruiting. ## **N.R.L.N. Continues to Fight for Retirees**

The National Retiree Legislative Network, Inc. better known as the NRLN is leading the fight to protect your retirement pension and health benefits. The ARR is a member of this Washington D.C. based organization and one of our ARR directors and Raytheon retiree Walter Justice serves on the board of the NRLN. In my opinion the NRLN truly represents the interests of all retirees and they are working hard to bring retiree issues to the attention of congress by introducing and promoting legislation that will protect retiree pension and health care benefits.

As an example, H.R. 1322 is a bill that NRLN will continue to pursue its passage. Introduced again in 2005 by Representative John Tierney (D-Mass.), it requires that companies retain and support all health care benefits employees have earned as of the first day of retirement. This means companies would not be able to unilaterally reduce your health care benefits as they currently are doing. NRLN is working to amend H.R.1, the Medicare Prescription Drug Act 2003 on several

important areas such as S.334, a bill that allows importation of prescription drugs from foreign countries under terms of specific safety controls. They are also evaluating the feasibility of drafting a bill, or petitioning members of congress to include provisions for competitive bidding that would keep drug prices in line. The present prescription drug act prohibits competitive bidding – can you believe that?

I have briefly highlighted only a couple of legislative issues the NRLN is actively pursuing for the good of all retirees.

ARR will continue to discuss pension and health issues directly with Raytheon Company but it is equally important that all retirees be aware of and support the efforts of NRLN.

Individual memberships are available which will provide you with a quarterly newsletter on important retiree legislative issues and other important related news that affect you as a retiree. As stated in one of NRLN's newsletters "as retirees, we seem to be hanging out there by ourselves, - no union to protect us, no management contract that we can invoke – we have only the law to rely on." Loyalty to retirees by current company management is disappearing. Laws must be changed to secure retiree pension and health benefits. NRLN can use your grassroots support.
